GENERAL INFORMATION

CROP SOURCE 0-0-9 is formulated for field, vegetable, row, fruit, tree, vine, ornamental and turf crops. CROP SOURCE 0-0-9 may be applied through drip systems, aircraft, or via ground sprayers (high-volume or low-volume).

CROP SOURCE 0-0-9 is compatible with most fertilizers and pesticides, however, a compatibility test is recommended if the desired combination has not been used in the past.

Directions for Use

CROP SOURCE 0-0-9 can be applied foliar, direct soil application or through any type of irrigation system. Check compatibility with a jar test prior to mixing.

General Recommendations

Cotton: Apply 2 – 4 qts/acre/application.

Peanuts: Apply 2 – 4 qts/acre/application.

Soybeans: Apply 2 – 4 qts/acre/application.

Vegetables: Apply 1 – 4 qts/acre/application depending on the size of the plants. Start applications prior to flowering and apply every 7 – 10 days up to first harvest.
