

# TOTAL K 0-0-15

## LIQUID POTASSIUM FERTILIZER

### GENERAL INFORMATION

TOTAL K is a high analysis liquid potassium fertilizer which can be soil applied as well as foliar applied. TOTAL K is highly soluble.

### APPLICATION

**Foliar:** On vine, field, vegetable and tree crops, apply TOTAL K at 2 to 6 quarts per acre each application, first at pre-bloom, then post-bloom, mid-season and pre-harvest. TOTAL K is intended to be used as a supplement to a soil applied fertilizer program. Use this product in at least 10 gallons of water for each gallon of TOTAL K.

**Soil:** On field crops, grains and vegetables, apply a side dressing of 2 to 8 quarts per acre at least 3 inches from the plant.

### COMPATIBILITY

Do not combine with pesticides that have restrictions concerning liquid potassium fertilizers. TOTAL K should not be mixed or applied with non-chelated nutrients such as calcium, copper, manganese, magnesium, iron or zinc compounds or antibiotics, sulfate or chloride salts or spray oils.

### CAUTION

Avoid applying TOTAL K if the crop is under heavy stress from pests, drought or in excessive heat.
