UPTAKE KMB is formulated for quick uptake of potassium for all crops. UPTAKE KMB can be used for foliar and soil applications on field, vegetable, row, fruit, tree, vine, ornamental and turf crops. UPTAKE KMB is formulated with potassium acetate, manganese, boron, and liquid humates. UPTAKE KMB may be applied alone or with fertilizers or pesticides. UPTAKE KMB is compatible with most pesticides and fertilizers. However, a compatibility test is recommended if the desired combination has not been used in the past.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. Follow all governmental procedures for the disposal of pesticide spray solutions. Rinse container, empty rinsate into spray tank. Dispose of empty container according to approved local practices.

DIRECTIONS FOR USE

Shake well before using. UPTAKE KMB is designed as a foliar or soil treatment. It may be run through irrigation systems.

RATE

Soil Application: Apply 2 to 4 quarts per acre in combination with fertilizer program.
Foliar Application: Apply 1 to 3 quarts per acre in combination with fertilizer program.
Repeat at 2 to 3 week intervals or as needed.
