CRUSTBUSTER is a formulation of non-ionic wetting agents and organic acids designed to break up the molecular structure of hard crusty soils allowing water penetration to the rooting areas of plants. CRUSTBUSTER helps save on repeated waterings, prevents puddling and aerates the soil. CRUSTBUSTER contains humic acid which will aid in conditioning the soil and increase the CEC capacity. When adding CRUSTBUSTER to liquid fertilizer, the components in this product will aid in the movement of nutrients to the root zone and allow the nutrients to become more readily available. CRUSTBUSTER is also an excellent tool for use with seed crops to increase germination.

RATES FOR USE

Broadcast Application:

Use 1-3 gallons CRUSTBUSTER per acre.

Banded Application:

Use approximately 1/2 - 1 gallon CRUSTBUSTER per acre.

CRUSTBUSTER may be also applied to liquid fertilizer at the above dosage.
