EXTEND-97 is an improved spreader-sticker for use with insecticides, fungicides, acaricides and pesticides, wettable spray powders and sun protectant sprays. It is a complex adjuvant designed to improve coverage deposit and retention. EXTEND-97 improves the weatherability of spray deposits. It reduces losses due to light rain, dews, and fog.

DIRECTIONS FOR USE

This product may be used in dilute or concentrate sprays.

PER 100 GALLONS OF SPRAY MIX

Acaricides and Fungicides..... 1/4 to 1 pint
Insecticides..... 1/4 to 2 pints
Wettable Spray Powders..... 1/4 - 1.5 pints
Sun Protectants..... 2 pints
Lower rates should be used in high volume sprays.
