FOAMSTOP 30 is an antifoam agent containing 30% silicone. FOAMSTOP controls foaming in emulsions, wettable powders and water based systems. It helps minimize entrapped air caused by mechanical agitation in spray tanks.

FOAMSTOP 30 MUST BE ADDED BEFORE PESTICIDE ADDITION TO PREVENT FOAMING.

This product may be used in dilute or concentrate sprays. Use 1-3 tablespoons per 100 gallons of spray solution.
