GENERAL INFORMATION

INTAKE is a high analysis spreader-activator which gives quick wetting, absorption and aids in assimilation and translocation. INTAKE is low foaming, nonionic, and is 80% active. It contains Humic Acid for increased translocation through the plant. It can be used with insecticides, miticides, herbicides, defoliants and fungicides.

DIRECTIONS FOR USE

This product may be used in dilute or concentrate sprays. Rates Per 100 Gallons or Less of Spray Mix Per Acre for Acaracides, Insecticides and Fungicides: Aerial application; 1-2 pints; ground sprayers; 1-2 quarts: Herbicides and Defoliant: 1-4 pints. Add INTAKE to spray tank first. Note: The above use recommendations are considered to be adequate for most uses. Some pesticides, however, may require higher rates for optimum effect. Follow the pesticide label directions when this occurs. However, do not add this product at a rate which exceeds 5% of the total spray volume.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. Keep in original container. Store in cool, dry place. Protect from excessive heat. Keep locked up and away from children. Do not reuse empty container. Triple rinse during mixing and loading and add rinse water to spray tank. Offer decontaminated containers for recycling or reconditioning, or puncture and dispose of in sanitary landfill. Contact county agricultural commissioner for container disposal information.

FIRST AID:

IF IN EYES: Immediately flush eyes with plenty of water, lifting the eyelids and rinse for 15-20 minutes. Remove contact lenses, if present, then continue rinsing. Call Poison Control Center or doctor for advice.

IF ON SKIN OR HAIR: Take off contaminated clothing. Rinse skin immediately with plenty of water for 10-15 minutes. Get medical attention if irritation develops or persists. Wash contaminated clothing before reuse.

IF INHALED: Move person to fresh air and keep at rest in a position comfortable for breathing if they feel unwell. If person is not breathing, call 911 or an ambulance, then give artificial respiration, mouth to mouth if possible. Call poison control center or doctor for treatment advice.
