

# SUPER HA 6%

## GENERAL INFORMATION

SUPER HA 6% is formulated for field, vegetable, row, fruit, tree, vine, ornamental and turf crops.

SUPER HA 6% may be applied through drip systems, aircraft, or via ground sprayers (high-volume or low-volume).

SUPER HA 6% may be applied alone or with fertilizers or pesticides. It can be applied either to the plant foliage or to the soil.

SUPER HA 6% is compatible with most pesticides and fertilizers. However, a compatibility test is recommended if the desired combination has not been used in the past. **USE CAUTION WITH FERTILIZERS WITH AN EXTREMELY ACIDIC pH, AS THIS MAY CAUSE THE HUMIC FRACTION TO PRECIPITATE.**

## DIRECTIONS FOR USE

All Crops:

Foliar Application:

Apply 1/2 to 1 gal/acre mixed with foliar applied materials as needed on a 10-14 day schedule. Dilute at least 1:20 in water if applied alone. Avoid foliar applications of SUPER HA 6% when plants are under stress due to lack of moisture.

Soil Application:

Apply 3-10 gal/acre (preferably 1/2 to 1 1/2 gallons applied over multiple applications.) It may be water run, side dressed, mixed with soil applied liquid nutrients or sprayed directly on the soil. When sprayed or side dressed without mixing with other nutrients, SUPER HA 6% should be diluted in 3-10 gallons of water.

Applications With Nutrients:

Apply 1/2 gallon up to 2 gallons of this product per acre mixed with the liquid nutrient. Add SUPER HA 6% to a partially filled tank. Include SUPER HA 6% with every application.

Transplanting or Cutting:

Mix 1/2 gallon of SUPER HA 6% per 20 gallons of solution.

Concentrate Application:

Use up to 2 quarts of this product in a minimum of 25 gallons of water per acre
