## GENERAL INFORMATION

CM CALCIUM 10% is formulated for field, vegetable, row, fruit, tree, vine, ornamental and turf crops.

CM CALCIUM 10% is compatible with most pesticides and fertilizers. However, a compatibility test is recommended if the desired combination has not been used in the past. Do not mix with highly alkaline materials.

Use Caution when mixing as this product is acidic. pH 2.5.

All Crops:

Foliar Application:

Apply 1 to 3 pints/acre as needed on a 10 - 14 day schedule in adequate water for optimal coverage.

Avoid foliar applications of CM CALCIUM 10% when plants are under stress due to lack of moisture.

Soil Application:

For fertilizer maintenance apply 1-3 quarts per acre.
